Dr. Stephen Voss has been on the University of Kentucky faculty since 1998. As part of his broader interest in cultural politics, he researches elections in both voting behavior and electoral rules. He has served as a consultant or expert witness in a half-dozen redistricting and voting-rights cases.

A nonpartisan analyst, Voss regularly appears in the news media as a political commentator, including as a regular guest on WVLK radio and occasional columnist for the Kentucky Lantern, and he works as a political analyst for Louisville's Spectrum One News. He holds a doctorate in government from Harvard University and two bachelor's degrees from Louisiana State University, one in journalism and one in history.
